OMIDRIA® (phenylephrine and ketorolac intraocular solution) 1% / 0.3% is a prescription medication used during cataract surgery. It helps the black part in the center of your eye (pupil) stay open (dilated) during cataract surgery and decreases eye pain after surgery. OMIDRIA has been proven safe and works well in adults and children.

# Cataract surgery

## What is a cataract?

A cataract can occur when the natural lens of the eye becomes cloudy due to age, trauma, a side effect of some medications, or if the cataract is present at birth.

Cataract surgery is a safe and common surgery in which the cataract is removed and replaced with an artificial lens.

Cataract surgery is performed by a specially trained eye doctor called an ophthalmologist.



## Cataract surgery checklist

Talking to your doctor about how to prepare can help you have a more comfortable cataract surgery experience. Here are some questions to ask:

### Before Surgery

- What is an intraocular lens, and what kind of intraocular lens may be right for me?
- Which medications will I need to take before my surgery?
- Will I need to arrange for someone to drive me home after my surgery?
- Do I have any medical conditions or other risk factors that could make cataract surgery more difficult?

### During Surgery

- Which medications will I receive during surgery?
- How long will my cataract surgery take?
- What can I do to ensure the best cataract surgery experience?

### After Surgery

- What can I do to keep my eye healthy after surgery?
- Which medications will I need after surgery?
- How long will it be before my vision improves?

This checklist provides common questions. Consult with your doctor about your specific condition.

OMIDRIA is the only FDA-approved combination medication used during surgery proven to **help your pupil stay dilated (open)**. This helps your surgeon see into your eye better.



OMIDRIA contains a nonsteroidal anti-inflammatory drug (NSAID), which **helps to control inflammation, swelling, and pain** both during and after surgery.

**OMIDRIA is the only combination medication approved by the US Food and Drug Administration (FDA) to help keep your pupil open during cataract surgery.**



Other medications used for this are called **compounded products**, which means they may be made by a pharmacist in a compounding pharmacy.



Compounded products **don't go through the same tests for safety**, strength, and quality as medications that are approved by the FDA.



The FDA and US Department of Health and Human Services **recommend using an FDA-approved treatment** versus a compounded one.

Ask your cataract surgeon about how OMIDRIA may help you have a better surgery experience.
